**GENERAL CLASSIFICATION**

Classification will be based on official averages and known ability. Shooters with no established average will be placed in not less than Class B in Singles and Doubles, and not less than the 20 yard line in Handicap. Ladies and Junior's with no established average will be placed in not less than Class C and not less than the 20 yard line in Handicap.
